Manufacturer Approval

Alwind has been approved as a supplier for the window units to meet the specifications required for this project. As per the specifications, the 5" mullion section is not suitable for all the window replacement locations and a reduced window mullion section will also be required.

Questions & Answers

- Q1. Can you please confirm what the intended schedule is for this project?
- A1. Window replacement within classroom and common areas are to be completed prior to August 31st, 2024. Window replacement within the office areas must be completed prior to March 31st, 2025.
- Q2. Please confirm if the windows sill are to be remove and replaced with new, if new please identified how many and provide specification for pricing purposes
- A2. Window sills are to be reused where ever possible. A line item has been added to the bid form (See revised Bid Form) to cover any sills that have pre-existing damage. Any damage to the sills during the window replacement or modifications required to the sills for the new window units must have costs covered in the base bid.
- Q3. There is no low-e indicated, would a Solarban60 be acceptable?
- A3. The proposed Solarban60 product is acceptable for meeting the Low "E" requirement of the Glazing specifications.

Designated Substance Information

The sealants/caulking associated with the window units are presumed to contain non-friable asbestos. Samples taken from the drywall & joint compound of the some of the offices walls within the project scope are confirmed to contain non-friable asbestos. Removal of asbestos-containing materials must follow the appropriate asbestos precautions for the classification of work being performed, and must be disposed of at a landfill approved to accept asbestos waste.
